



Upstream Fund

Community-led and system supported approach to improving safety and wellbeing in Waterloo Region

> The goal of the upstream fund is to reduce harm and systemic barriers to improve safety and wellbeing

Upstream Initiatives address the root causes of harm By engaging diverse grassroots groups, the collective impact of the projects will improve our Region

The vision for this work builds off of three important principles: Relationship Building, Peer Engagement and Collaboration
