## **Community and Health Services Committee**

## **Summary of Recommendations to Council**

The Community and Health Services Committee recommends as follows:

- That the Regional Municipality of Waterloo direct staff to take the following actions in response to Ont. Reg. 241/22 and Ont. Reg. 242/22, new regulations under the Housing Services Act, 2011 (HSA), as described in CSD-HOU-23-008 dated March 7, 2023:
  - a. Draft and negotiate a funding model that achieves the legislative directives and supports long-term financial sustainability of the community housing portfolio for housing providers to meet their operating and capital needs upon End of Mortgage (EOM);
  - b. Subject to annual budget approval, direct staff to develop an annual housing reinvestment plan using the funds resulting from community housing provider mortgage maturity for the purpose of:
    - i. Maintaining or increasing the number of rent-geared-to-income (RGI) units to meet the Region's obligations under the HSA; and
    - ii. Providing capital funding for asset renewal needs of community housing providers; for the renewal and expansion of Waterloo Region Housing properties, including investments within the Waterloo Region Housing Master Plan; and grants to incent the construction of new affordable housing units;
  - Authorize the Commissioner, Community Services to enter into service or exit agreements as housing providers reach EOM in a form satisfactory to the Regional Solicitor;
  - d. Amend the current surplus-sharing practice within the mandated funding model to allow community housing providers to retain annual operating surpluses subject to the following conditions:
    - The amount of the surplus transferred to a provider's capital reserve is limited such that the balance in the capital reserve will not to exceed the value of capital work identified for the next five years, and;
    - ii. Capping the accumulated surplus at \$500/unit;
  - e. Endorse a new Asset Limit Policy required by Ont. Reg. 242/22 to establish asset limits of \$75,000 for single households and \$100,000 for households with more than one person for households applying for and receiving rent-geared-to-income (RGI) subsidy.
