I introduce myself before you, I am Colombian citizen, unfortunately I came with my husband for protection claim to Waterloo region on 2019, appealed in Toronto on 2021, until today we have not immigration status because multicultural center settlement manager and settlement worker interference in our immigration process and different accessing for services and specially blocking our opportunity of relocating in Alberta province just because their prejudice and personal pride and over controlling of confidential information of our marriage, going to decide behind us our life without say us a word from 2021. Add their participation of personal revenge in Kitchener of the Idmji church pastor and the marriage host giving manipulated versions about us and supported with gossip, rumors and envy, international revenge of Idmji Ecuador church main pastor using the platform of the church to defame and block our establishment in Canada. Honestly, we are so affected and even more after noticing all personal damage from 2021 when we expected help from IRCC Toronto to flee of Kitchener and instead we have been terrible exposed to abuse, over-monitored and hurt us until today because Ana Martinez and Eunice Valenzuela and Daniel Mijet, the manager of the building took us by their own because we are fighting for right of decision, what to do and how to do and where to do, it is this impossible of forbidden in Waterloo Region as mentioned make feel us, however thanks to Liberal Party of Canada welcoming to me to training with about policy, leadership and Canada I got confidence again and renew my own leadership for women rights and minorities rights because the experience of barriers and harassment as woman and as Colombian immigrant just move me for public service contribution, next I will give my vision and suggestion for community of Waterloo Region.

6. Communication and Engagement with Area Municipalities and the Public

Area Municipalities: To incentivize the development of affordable must to incentivize new licenses for business and new creation of jobs and employment resources that connect with mobility through towns.

It needs too much effort to promote economic development, the issue of housing is a reflection of an employment lack, employment barriers and reduced options to get income.

Public: Ongoing engagement and consultation with community partners and service providers occur on housing and homelessness issues through various programs and specific working groups.

Partners and service providers must be recognized and awarded for their previous contribution and invited to participate in other spaces to forward people inside the community system.

Be invited to innovation of tools, methods, vision of the world and specially to agree with the social change from the positive side instead to avoid it and block the initiatives.

Different and never contacted community members must be called. Fight against monopoly.

Can be a fully subsidized bus that moves people among towns around the city to spread relief of mental and social issues for the vulnerable sector.

GRT deserves more support for increased mobility options, maybe giving sub-license to other alternatives of vehicles , mobility, mobility and mobility.
